GREEN BAY AREA YOUTH HOCKEY ASSOCIATION
PARTICIPATION OBLIGATION AGREEMENT 2008-2009 SEASON

Consistent with past standard club practices and the registration process, completion and return of this document is required before your child's skating can begin.

The fund raising aspect of our organization is a vital part and it requires 100% cooperation from its members to be successful. Its purpose is to hold our participation costs to a minimum. As a participating member of GBAYHA, please understand that these requirements benefit all skaters in the association, and provide us with a sound foundation for support of the programs offered.

For the 2008-2009 season fundraising efforts of the association will include, but are not limited to the following: Rink Concession Stand/Golf Outing/Calendar Raffle Ticket sales (10 tickets per skater, maximum 20 tickets per multi-skater family). These fund-raisers are our most profitable events and are extremely important to the needs of GBAYHA. These fund-raisers must be fully staffed before any other event will be considered for credit allowances. There are several open credit positions that are listed in the Newsletter, on the website, and/or posted at the rink.

NO OTHER CREDIT ALLOWANCE WILL BE GIVEN UNLESS APPROVED BY THE GBAYHA BOARD OF DIRECTORS.

2008-2009 SEASON REQUIREMENTS

All guardians of skaters enrolled in GBAYHA programs will be responsible for the following requirements:

1. Complete 4 credits per skater (maximum 12 credits per family). Only the following are exceptions:
 - *Mighty Mites (formerly Mite Rec) – **2 credits** per skater
 - *HIP (Hockey Initiation Program) -- **No credits required**
2. You are **required** to sell at least **10 raffle tickets** per skater (maximum 20 per multi-skater family). Calendar stubs and money must be turned in no later than December 27, 2008. Only the following are exceptions:
 - *Mighty Mites, (formerly Mite Rec) – **5 raffle tickets** per skater
 - *HIP (Hockey Initiation Program) -- **Raffle ticket sales encouraged, but not required**
3. **You will be responsible for 6 or more hours of work during your home tournaments.****
****If you fail to complete this responsibility you will be charged \$100.00 (Team Managers should notify Lynn Niemi, Credit Chair, with names of those failing to participate – \$100 will come out of your credit check.)**

The team rink cleaning weekend has been eliminated. The cost for rink cleaning has been reflected in the fees.

ADDITIONAL INFORMATION:

1. This form must be signed by a parent/guardian and returned for your registration to be complete.
2. If your credits (or other fee obligations) for the **2007-2008** season have not been worked or paid, you will have to pay last year's fees/credits before registration is complete.
3. **High School (Girl) Seniors and out of area skaters** will have to prepay a jersey deposit of \$200.00 at the time registration is due. Jersey deposits will be refunded once jerseys are returned.
4. Only credits approved by the Board of Directors will qualify for credits earned. There are **no exceptions**.
5. Credits may be bought at \$100.00 per credit.
6. All skaters must prepay their credit obligation of \$100.00 per credit (**\$400/SKATER & \$200 for Mighty Mites, and Girls U10**). This should be a separate check payable to GBAYHA and dated February 28, 2009. Your uncashed check will be returned after Feb 28, 2009 if all credit obligations have been satisfied. If you have not fulfilled your credit obligations by Feb 28, 2009, your check will be deposited and a refund will be sent to you for the credits fulfilled.
7. **NOTE: If a credit is committed to, but then not worked, your \$400 credit check will be cashed and a refund issued for any credits worked.** You will not be allowed to work in lieu of the one missed. However, if you have someone fill in for you and they indicate on the sign in sheet that they are working for you, you will be given completion of a credit. **FINDING A REPLACEMENT IS YOUR RESPONSIBILITY, NOT THE SCHEDULER'S!!**

Any skater whose fees have not been paid or forms have not been completed and returned to the registrar will not be rostered on a team with WAHA until paid/completed. Any skater not rostered by December 15, 2008 will not be allowed to skate.
